### **RESOLUTION NO. 2491**

# A RESOLUTION AMENDING SECTION 2, PUBLIC SAFETY, OF THE FEES AND CHARGES SCHEDULE ADOPTED BY RESOLUTION 2473.

#### THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:

- 1. On October 22<sup>nd</sup>, 2019, the City Council adopted Resolution 2473 which enacted new parking and vehicle violation fines.
- Since that time Multnomah County has requested that all the jurisdictions it serves adopt a uniform fine schedule for parking and traffic offences under the City Ordinances.
- The City Council has found that a uniform fine schedule will save the costs of multiple versions of the citation used by deputies and will minimize confusion for the deputies.
- 4. The City Council has found that the minor determinant of a few fines being greater than the current fines does not outweigh the benefit of a uniform fine schedule
