

## **RESOLUTION NO. 2400**

### **A RESOLUTION APPROVING THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF WOOD VILLAGE AND THE CITY TO PROVIDE COURT SERVICES**

#### **THE TROUTDALE CITY COUNCIL FINDS AS FOLLOWS:**

1. The City of Wood Village and the City have had a long history of cooperation in the improvement of services to the citizens and the business community.
2. Wood Village wishes to enter into an intergovernmental agreement with Troutdale for the provision of court services described in this agreement; and
3. Troutdale is agreeable to provide such services on the terms and conditions set forth herein; and
4. Parties have authority to enter into this intergovernmental agreement pursuant to the powers contained in their respective charters, and as identified in Oregon Revised Statutes, chapter 190, granting the ability for governmental entities to jointly exercise authorities through agreement, and
5. Parties more specifically have the authority under both ORS 221.355 and their home rule authority to reach an "Agreement Between Cities for Judicial Services".

#### **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROUTDALE**

Section 1. Agrees that it should enter into an IGA with the City of Wood Village to provide shared court services substantially in the attached to the Staff Report.

Section 2. Designates the City Manager or Finance Director (each a "City Official) or designee of the City Official, to act on behalf of the City, and without further action by the City Council. The City Official is hereby authorized, empowered and directed to sign the IGA on behalf of the City, and any and all other required and necessary documents to implement the intent of the agreement.


Section 3. The City Official is hereby authorized to execute, acknowledge and deliver the IGA in substantial conformity with Exhibit A of the Staff Report, including any other supporting and implementing documents, and to take any other action as may be advisable, convenient, necessary, or appropriate to give full force and effect to the terms and intent of the IGA, and the execution thereof by any such City Official shall be conclusive as to such determination.

Section 4. Further, consistent with the intent of the IGA, and in the best interest of the City, the City Official is authorized to determine, execute, acknowledge and deliver any subsequent addendums, extensions, revisions, modifications, or successor documents

of the IGA, and the execution thereof by any such City Official shall be conclusive as to such determination.

Section 5. This Resolution shall take effect immediately upon adoption.
